




That the Rainbow Valley Corporation, a Texas Corporation authorized to do business in the State of Colorado, Dean F. Chaussee, Agent and Attorney in fact, being the party in interest to the following described tract of land;

TO WIT; That portion of Section 24, Township 13 South, Range 47 West of the 6th Principal Meridian, described as follows:
