


Commencing at the Northeast Corner of said Section 24; thence N89°18'13"E, along the North line of said Section 24, on an assumed bearing, to which all others in this description are relative, 3870.78 feet to the Northeast Corner of the W1/2 E1/2 of said Section 24; thence S 02°25'06"W, along the East line of said W1/2 E1/2, 1749.93 feet to the Point of Beginning of the tract to be described, said point being N02°25'06"E, 551.27 feet from the Northeast Corner of "PINECLIFF NO. 1" as recorded in Plat Book R-2 of Page 69 of the Records of El Paso County, Colorado; thence N69°54'18"W, 176.39 feet; thence S43°08'57"W, 400.00 feet; thence S 7°38'57"W, 260.00 feet; thence S3°38'57"W, 158.25 feet to the Northwest Corner of the aforementioned PINECLIFF NO. 1; the following seventeen (17) courses are along and coincident with the Northern boundary of said PINECLIFF NO. 1: thence S78°22'00"E 182.00 feet; thence N14°07'00"E, 72.00 feet; thence S75°53'00"E, 231.49 feet to a point on a curve to the left, which curve has central angle of 11°48'29", a radius of 252.80 feet; thence S73°38'29"W to the tangent of said curve, an arc distance of 52.10 feet; thence S4°10'00"E, tangent to the last mentioned curve, 20.00 feet; thence S79°52'00"E, 116.00 feet; thence S43°56'00"E, 80.50 feet; thence S8°33'00"W, 94.00 feet; thence S36°30'00"E, 158.00 feet; thence S70°29'00"E, 186.00 feet; thence N76°07'00"E, 121.00 feet; thence S40°07'30"E, 130.00 feet; thence N32°00'00"E, 216.25 feet; thence S65°05'25"E, 97.21 feet; thence N27°43'30"E, 70.15 feet; thence S66°05'25"E, to the tangent of a curve to the left, which curve has a central angle of 65°15'54", a radius of 125.00 feet; thence mentioned curve, 60.04 feet to the aforementioned Northeast corner of PINECLIFF NO. 1; thence N02°25'06"E, on the East line of the aforementioned W1/2 E1/2 of said Section 24, 551.27 feet to the Point of Beginning and containing 24.917 Acres more or less.

The above parties in interest have caused said tract of land to be plotted into Lots, Blocks, Streets and Easements as shown on the plat. The undersigned do hereby grant unto the City of Colorado Springs those easements shown on the plat and further restrict the use of all easements to the City of Colorado Springs and/or its officers, provided however, that the sole right and authority to release or Quit Claim all or any of such easements shall remain exclusively vested in the City of Colorado Springs. All streets are hereby dedicated to the City of Colorado Springs for public use. This tract of land as herein plotted will be known as "PINECLIFF NO. 2" in the City of Colorado Springs, El Paso County, Colorado.
